Dear Colleagues,

With only three months to go, 5 May is fast approaching! This month's newsletter introduces more information on the activities proposed for this year's annual focus: **the role of hand hygiene in combating antimicrobial resistance (AMR)** and aims to support you in organizing your plans and actions.

1. 5 May 2014 – call for action

A reminder, the goal for 5 May 2014:

- To highlight the role of hand hygiene in combatting AMR by making sure the WHO 5 Moments are core to protecting patients from resistant pathogens.
- To emphasize the problem of AMR that can arise from patient care interventions.

On this new, dedicated web page WHO has now launched:

- Updated information outlining all of the tools and activities WHO is promoting (as featured in last month's newsletter).
- A new activities 'prompt' list to guide you on planning, acting and communicating in support of 5 May. For example, the planning section prompts are:
 - Prepare a (local) plan with deadlines for organizing activities/messages leading up to 5 May and plan to visit www.who.int/gpsc/5may/en regularly for updates and to access new documents and tools issued by WHO.
 - Share the (local) plan with all those who need to approve it and/or will be involved in the activities.
 - Plan dates to highlight results of 5 May activities, including from the WHO surveys and recommended 'contamination' exercises in your area.

- More detail on how to conduct some local activities as outlined in January's newsletter:
 - Taking cultures of health-care worker hands - to highlight hand contamination and the importance of hand hygiene action.
 - Contaminating the environment with glow powder to highlight where it has spread to over time, in the environment and on staff hands – again illustrating the power of the WHO 5 Moments as a barrier to stop the spread of organisms to patients and staff.

The focus for you this month is ***'Get ready to participate in the WHO surveys in March!'***

In line with the theme of 5 May 2014, WHO will invite health-care facilities to participate in:

1. A WHO Global Laboratory-based Survey on MULTIDRUG-RESISTANT ORGANISMS (MDROs) in Health Care.
 - This is a global prevalence survey on the burden of MDROs from clinical specimens routinely submitted to participating laboratories for inpatients. The survey is based on the routine collection of blood and urine (MSU & CSU) culture specimens and will be focused on five selected key MDROs pathogens:
 - Methicillin-resistant *Staph.aureus* (MRSA)
 - Vancomycin-resistant enterococci (VRE)
 - Extended-spectrum β -lactamase (ESBL) producing Gram negatives
 - Carbapenem Resistant Enterobacteriaceae (CRE), and
 - Multi-resistant *Acinetobacter* spp (MRAB).
 - Laboratories will be asked to report the first isolate from inpatients over one continuous week (7days) any time from 1-23 March 2014.
 - Data will be returned to WHO through a single electronic form, provided by WHO, by 31 March.
2. A WHO Global Prevalence Survey on the use of SURGICAL ANTIBIOTIC PROPHYLAXIS.
 - This survey is aimed at obtaining a snapshot of the prescribing of antibiotic prophylaxis, from patient records, in surgical wards in a wide range of acute health-care facilities.
 - Data collection will be requested on *one day only* (ideally on a *Wednesday* or a *Thursday*) between 12 and 31 March 2014, on all patients who have undergone *surgery* in the *three previous days*, prior to the survey day.
 - Any acute health-care facility can participate, with the option of choosing any number of general surgery and/or gynaecology and obstetrics wards.
 - Data will be returned to WHO through an electronic database, provided by WHO, by 7 April.

Important information concerning both surveys:

- Complete instructions will be available on the [WHO web site](#) in the next 10 days.

- At the beginning of March, health-care settings participating in **SAVE LIVES: Clean Your Hands** will receive invitations to participate through an online system allowing individual protected access.
- The surveys are quite simple to complete and will not be very time-consuming.
- We are keen to receive results for both surveys from your health-care facility! If this seems unfeasible, please do prioritize to undertake one of the two.
- WHO will be the only recipient of the data and commits to keeping individual facility names and results strictly confidential. Results will be summarized by country and issued on 5 May 2014.
- It is crucial that you begin planning NOW to undertake these surveys!

Please promote the WHO surveys and make sure those you talk to and who want to take part are registered for **SL:CYH**.

2. **SL:CYH registrations**

Remember our registration goal in 2014: to have at least one registered facility in each country and therefore to have entire WHO regions with all countries having registered facilities.

- Check out the [list of registered and non-registered countries](#) regularly to keep motivated on getting those who you talk to sign up for the campaign.
- Please make every possible effort to share the registration call to action with colleagues. You can share this newsletter or highlight the web link of where to register when giving presentations – use the global map available on the registrations web page.

3. Working in collaboration

The team at WHO has been contacting many international and national organizations and

has received confirmations that they will spread the messages for [SL:CHYs 5 May 2014](#) – thank you to everyone.

- One example is the infection prevention and control society in New Zealand which is eager to help engage those facilities in the Pacific Islands who have not yet registered for the campaign.
- Another example is the International Federation of Infection Control (IFIC), which each year promotes the campaign to the many societies that are part of their group.
- Next, the World Alliance Against Antibiotic Resistance has disseminated key messages to its members across the world.
- A number of international journals are also featuring a [5 May advertisement](#) that is also available for all to use on their [web pages](#).
- Lastly, the ‘Turn Africa Orange’ campaign supported by ICAN (see January newsletter), is extremely active and is reaching many in this continent. We thank all those who are working hard to engage health-care facilities across this region and we will be tracking their progress in getting new registrations!
- And for interest, our Private Organizations for Patient Safety (POPS) collaborative is also supporting 5 May; you may find a number of companies actively promoting and supporting the same messages. Further information on this initiative and those involved can be found [here](#).
